

Chaplin Recreation Commission
Regular Meeting Minutes.
September 16, 2021

1. Call to order: 7:04pm by Chairperson Dave Stone. Present: Josh Woodward, Monica Arbo, Penny Boomer, Amelia Nelson, Dave Stone.
 2. Audience for Citizens: None.
 3. Additions to Agenda- Added discussion on a barn clean out and information for the sound system, and movie night.
 4. Secretaries Report: Dave makes a motion to approve 8/26 meeting minutes. Josh Woodward 2nd. Monica Arbo abstained. 3-1-0. Motion passed.
Monica makes a motion to approve 9/1 meeting minutes. Dave Stone 2nd. Penny Boomer abstained. 3-1-1. Motion passed.
Dave makes motion to approve 9/9 meeting minutes. Penny 2nd. Monica and Josh Woodward abstained. 2-2-0. Motion passed.
 5. Treasurers report: General funds: \$13,721.85. Special Revenue as of Aug 31: \$10,812.85
Waiting to pay Three57 \$400 for cancelled show from general funds. Waiting to pay out for cornhole summer league play offs.
 - A. BJ's membership: Penny looked into credit card options through BJ's. If you have 2 people with membership on the credit card it is \$110 annual fee with 5% cash back. Or same plan option with unlimited people for \$160 annual fee.
Penny makes motion to get BJ's membership for \$160 for unlimited users. Dave 2nd motion. 5-0-0 motion passed.
7. Sports:
- A. Basketball: Matt is still working hard to get more answers from league D12 Brad from Columbia. There's a chance there won't be a basketball league this coming fall/winter.
 - B. Soccer: Off to great start with coach Melissa. Collected \$440 out of \$560 that was paid out.
 - C. Disc Golf: spoke with Brian Bombria on phone about disc golf tournament. No specific date was set yet. He would like to use course at Garrison Park on a weekend to play 2 rounds of 9 totalling 18 holes. He is looking to ask \$30 per person. \$20 to the tournament and \$10 to supplies/donation to the park. Expected amount in \$300 in donation to the park. Suggested rec could sell concessions. Tentative dates were tossed out of October 16th or October 23rd.
Dave makes motion to sponsor Brian Bombrias Disc golf "Fall45" tournament at the park October 16th or 23rd contingent availability. Contingent \$10 per person coming back to the commission. Josh Woodward 2nd. 5-0-0 Motion Passed.
Dave makes motion to spend \$100 on supplies for tournament. Monica 2nd. 5-0-0 Motion passed.
8. Activities:
- A. Halloween: Voted to plan a drive thru for halloween again this year.
Asking for trunks registered through town with covid policy information.

Need to be registered in order to set up. Planned for October 31st the day of Halloween from 6-8pm. Previously approved \$1500 for decor only.

Penny makes a motion to spend up to \$500 on candy for halloween. Dave 2nd. 5-0-0 Motion Passed.

- B. Cornhole- Everything looks good so far, Fall league starts soon!
- C. Rec logo- Nothing new. Still looking for ideas to present to members.
- D. Town Wide Tag Sale- Josh Woodward makes a motion to cancel at the park tag sale and return registration fees to currently registered people. Sending out advertisement for people at home. Penny 2nd. 5-0-0 Motion Passed.

Due to low registrations discussion was made not to hold spots at the park for the tag sale.

9. Building and Field:

- A. Fence between Park and Hubbard: Talked about scheduling posts to go in. Still have rails to stain, but getting closer to being done.
- B. Playscape Phase 2: We are looking at Early October to be finished with the playscape!
- C. Barn Cleanout: Discussion on communicating to all of rec members to set up a day to clean out the barn and get organizing.
- D. Sound System: Discussed getting wireless bluetooth speaker for events or options to make current speakers compatible with all devices for music and other things. Josh Woodward makes a motion to purchase bluetooth connector for speakers in the shack. Dave 2nd. 5-0-0 Motion passed.
- E. Movie Night: No more movies are planned for the remainder of the year. We will discuss for a plan next year!
