CHAPLIN BOARD OF FINANCE Chaplin, Connecticut <u>Meeting Minutes</u> October 13, 2015

 - a. June 30 Collection Reports; FY 14-15 Collection Review; overall status of delinquent taxes: The Board was presented with Tax Collection Report. Collections are on target. *Motion to accept Tax Collection Report for FY 2014-15 as presented, was made by Jean Lambert, seconded by Bruce Raymond and carried unanimously.*

The Financial Statements are in good shape.

Treasurer: Monthly report

The Board was presented with a report on the banking fees. There are four accounts in Webster Bank that are used for tax collections. Annual fees are \$3,900 that is offset with interest by keeping approximately \$350,000 in this account. Last year's fees were \$6,800 with Bank of America. Most of the funds are in the Savings Institute with a verbal agreement to never charge a fee (there have been none to date). There is a line item in the budget for banking fees.

Doug Dubitsky commended Andrew Daniels for his fabulous work as Treasurer. The Board also commended him for his great work and he will be sadly missed.

• Selectmen's Meeting - October – R. Weingart: Dick Weingart presented the following highlights from the Selectmen's Meeting:

- The Mansfield Boundary Survey resulted in one property in Chaplin and another property with the boundary line going through the middle of a house. Research is being done to resolve the issue.
- A gas pipeline crosses Bujak Road and Tower Hill Extension. There are huge ruts that will be fixed by the gas company.
- Discussion was held regarding reorganization of Public Works due to the July 2016 retirement of Steve Guay. Dick Weingart will check with the First Selectman regarding the potential cost of benefits pay out.

Motion to recommend to a Special Town Meeting an appropriation for fiscal year 2015-16 in the amount of \$28,275.00 to account 37100-Resident Trooper Salary from account 10702-Unrestricted General Fund, was made by Diane Fiasconaro, seconded by Jean Lambert and carried unanimously.

c. Consider and act on recommendation that the sum of \$450,000 in previously awarded STEAP Grant funds be transferred from the Bedlam Road Bridge project to the North Bear Hill Road Bridge project, subject to final approval at a Town Meeting:

Motion to recommend to a Special Town Meeting a transfer within the CIP Fund in the amount of \$450,000 to account 3315.1.b STEAP-North Bear Hill Bridge from account 3315.6-Bedlam Road Bridge, was made by Jean Lambert, seconded by Bruce Raymond and carried unanimously.

Motion to transfer \$726.67 to account 44103-Dial-a-Ride/WRTD from Account 50000-Town Contingency Fund, was made by Jean Lambert, seconded by Bruce Raymond and carried unanimously.
