CIP COMMITTEE MEETING Chaplin Town Hall April 2, 2014 Minutes

1. <u>Call to Order</u> Bill Rose called the meeting to order at 7:05 pm.

2. Members Present

3. <u>Discuss and Act on CIP Plan</u> <u>General Government</u> Assessor: Added \$12,000 to 2018-2019 CIP

North Bear Hill Bridge Replacement

Changed 2014-2015 proposed CIP from \$95,000 to \$80,000 and raised 2015-2016 CIP from \$31,000 to \$46,000.

Conservation Commission – defer from 2014-2015 to 2015-2016

<u>Relocate Museum</u> Price under \$20,000 to move the museum itself and another \$20,000 for other things. A committee will eventually be put together.

<u>Senior Center/Library</u> HVAC System – current system will require replacement. Added \$60,000 for 2018-2019 CIP.

<u>Public Safety</u> Added \$15,000 to 2015-2016 CIP for a Thermal Imaging Camera Added \$5,000 to 2018-2019 CIP for new SCBA Bottles Added \$6,000 to 2018-2019 CIP for Firefighter Gear Replacement Added \$25,000 to 2018-2019 CIP for a Multi-purpose truck Added \$12,000 to 2016-2017 CIP for a JD Gator (or similar) and a Transport Trailer Added \$10,000 to 2017-2018 CIP for a Gator Skid Unit

Public Works Department

Road Maintenance – Added \$223,440 to 2018-2019 CIP for road maintenance, which is the usual 5% increase

With regard to the Parish Hill Road Drainage – hopefully that work can be started soon. The money allocated is mostly for materials.

Added \$30,000 to 2014-2015 CIP for the Tower Hill Road Bridge Deleted for 2014-2014 the \$25,000 that was already in place and slid it over to 20-15-2016 for a total for that period of \$50,000. Added \$25,000 to 2018-2019 CIP for replacing the plow truck. Added \$50,000 to 2014-2015 CIP to replace the JD Payloader with a backhoe. Mr. Rose said that the backhoe is in poor shape. We may want to do the replacement sooner rather than later.

The new totals are as follows – 2014-2015 - \$371,000; 2015-2016 - \$367,000; 2016-2017 - \$320,150; 2017-2018 - \$324,800 and 2018-2019 - \$356,440
