OLD BUSINESS:

A. 80 Marcy Road:

J. Gigliotti presented update on 80 Marcy Road with photos taken today and photos from last month with minimal progress since the last meeting (screen door removed) and no contact from the owners. 4 vehicles, 2 RVS, 2 boats and debris still remain on the property (dumpster was removed). Discussed water issue with driveway being washed out including: impact of not having a driveway apron, pipe under driveway that overfills with heavy rain and spills out.

B. Dubos asked if passing of nips would be a PZC issue (not a zoning issue). Legislation passed last year for a 10cent environmental fee (town gets 5 cents to pick up nips on side of the road and 5 cents goes to the state). Redeemable bottles and cans are stamped with CT 10 or CT RV (redemption value) that ties in with bar code (red labels used for non-redemption states).

Emails received from Pat Pogmore asking if any changes to Chaplin Zoning Regulations to allow permaculture retreats in residential agricultural zone by special permit (Chaplin decided not to allow) and what Chaplin has done regarding affordable housing mandates (plan put in the POCD, amended accessory apartment regulations to allow more use in the business zone).
