- **4. Review of the Central Office Committee Compact** Discussion to revisit the Central Office Committee Compact as an agenda item at the next Committee meeting so it can be reviewed by the committee members.
- **5. Discussion of Region #11/Chaplin Assessment Ratio Percentage for FY 18-19 Budget** Superintendent Ken Henrici provided handouts for the COC Assessment calculation based on enrollment as of 10/1/16 and enrollment as of 10/1/17 for CES (Pre-K through Grade 6) and PHHS (Grade 7 through Grade 12, Outplaced, Vo-AG, and Magnet).
  Jaclyn Chancey moved to adopt the Assessment based on the official enrollment as of 10/1/2017. Sally Ireland seconded and the motion passed unanimously.
- **6. Preliminary FY 18-19 Budget Update** Superintendent Ken Henrici and several COC members recommended moving to a Business Manager model from a Financial Supervisor model. There was discussion regarding the creation of a Job Description which Rose Bisson will bring an example of to the next meeting. This item will be revisited at the next COC meeting. The COC also asked for a legal opinion regarding Marcia McGinley. The legal question is whether Marcia McGinley can be in a Parish Hill administrators' bargaining unit while at the same time, being listed as a Central Office employee whose salary for Parish Hill and Chaplin is included the COC budget. The COC requested a legal opinion from the Board Attorney.
