A. Basketball:

Discussed registration fees - \$100 for Chaplin residents, \$120 for out-of-town residents (Matt will post registration online and inventory supplies needed, Amie will make flyers). Amie Kraemer suggested requiring parents to sign contract that they are not allowed to talk to refs similar to what's being done for soccer (Dave will work on Code of Conduct).

- Motion to spend up to \$50 per player for jerseys and shorts (if needed), made by Dave Stone, seconded by Danny Cates and carried unanimously.
- **B. Soccer:** Coach Melissa wants to do indoor winter soccer at the school (Amie will contact for proposal).

8. Activities

A. Halloween:

Halloween at the Park will be held on Saturday, October 26th with Trunk or Treat.

Motion to spend up to \$1,500 on Halloween decorations, made by Danny Cates, seconded by Amie Kraemer and carried unanimously.

B. Other: None

9. Building and Field:

A. Barn door replacement:

Upper barn door is unsecure and needs replacement. Received \$1,289 quote from American Overhead Doors for conventional overhead rollup door installed (would require DPW to pad out and shrink the frame to make it fit).

Motion to approve \$1,289 plus \$200 from the General Fund for overhead rollup door and incidental framework to be installed by DPW, made by Dave Stone, seconded by Danny Cates and carried unanimously.

B. Race track:

Two ballfields (Little League, softball) maintained by the town (\$2,500 year) are not used. Dave Stone suggested turning the softball field into a multi-use track (minimal cost) and continue maintaining the Little League field. The track could be used for lawnmower races, go-kart races, horse shows, or BMX track with removable bumps. The Commission endorses the idea – Dave will work on proposal to present to the Board of Selectmen (Matt suggested checking with insurance company).

 Motion to approve \$100 for Food Trucks, \$20 for Non-Food Vendors, and no charge for Chaplin entities and non-profits for Chaplin Day 2025, made by Dave Stone, seconded by Amie Kraemer and carried unanimously.
