A. Review application for zoning variances on #82 Cross Rd for setback relief of detached garage, Applicant Towne Engineering, Owner Kevin Smithwick:

Matthew Maynard from Towne Engineering with property owner Kevin Smithwick presented maps for proposed detached garage on 82 Cross Rd in the RAR District (4.72 acres). Asking for variance for reduction of rear setback (30ft to 5ft) and reduction of side setback (20ft to 15.1ft) due to slope that would require tremendous amount of earthwork and wetlands disturbance. Bill Rose asked if the setback was discussed with the neighbors (neighbor on the side yard is fine with the variance, will discuss with rear yard neighbor) and asked if the neighbors could attend the Public Hearing to comment on the variance or provide a letter if they can't attend. Rosalie Gifford and Therese Smith would like to do a site walk. Therese Smith asked what the neighbor has on the rear side (all woods) and asked what would happen if the proposed garage was turned north to northwest (would lose the turnout to the garage with difficult access for emergency vehicles).
